Description and usage:

The paired temperature sensors TP 15 are used as separate component parts of heat-quantity meters and they are provided by temperature sensing elements Pt 100, Pt 500 and Pt 1000. Stainless steel thermowells of the class 17240 are delivered as an accessory. The parts of the sensors are fixing plugs for thermowells and identification labels. Standard measurement range for using is 0 to 180 °C and 0 to 150°C. The sensors are designed to be operated in chemically non-aggressive environment.
